



VERIFICATION STATEMENT WATER WITHDRAWAL

Bureau Veritas North America (BVNA) was engaged to provide conduct an independent verification at a limited assurance level of the water withdrawal reported by Symantec Corporation (Symantec) for the period stated below. This Verification Statement applies to the related information included within the scope of work described below.

The determination of the water withdrawal is the sole responsibility of Symantec. BVNA was not involved in determining the water withdrawal. Our sole responsibility was to provide independent verification on the accuracy of the water withdrawal information reported, and on the underlying systems and processes used to collect, analyze and review the information.

Boundaries of the reported data covered by the verification:

- Operational Control
- Worldwide
- Exclusions from the scope of the reporter's data assertion:
 - Data outside the defined assurance period of fiscal year 2015 (April 1, 2014-March 31, 2015)

Data verified:

- **Water Withdrawal:** 791 megaliters

Data and information supporting the water withdrawal assertion were historical in nature.

Period covered by verification:

- April 1, 2014 to March 31, 2015

It is our opinion that Symantec has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of water withdrawal for the stated period and boundaries.
